#### Obama signs aid bill into law

President Barack Obama Thursday signed \$7.5 billion Kerry-Lugar-Berman Bill into a law, with the White House reaffirming strategic partnership with Pakistan, a day after Congress attached an explanatory statement to address the South Asian anti-terrorism ally's concerns over parts of the legislation.

# Pacts, MoUs signed on space technology, energy

Pakistan and China on Thursday signed two agreements and Memoranda of Understanding (MoUs) on Space concessional loan, space technology and alternative energy. Prime Minister Yousuf Raza Gilani witnessed the signing ceremonies as the respective officials of the companies inked the documents. The concessional loan agreement for Paksat was signed between Pakistan's Economic Affairs Division and Export Import Bank of China.

# Islamabad and Beijing to enhance trade to \$15 billion by 2011

Prime Minister Yousuf Raza Gilani and Chinese Premier Wen Jiabao on Thursday expressed their resolve to further strengthen bilateral ties in economic, defence and energy sectors for mutual benefit of the two countries.

#### Net hydel profit: Gilani supports Punjab government

Prime Minister Yousuf Raza Gilani has reportedly supported the Punjab government in getting the much delayed Net Hydel Profit (NHP) after the Chief Minister wrote a very strongly worded letter to him, official sources told *Business Recorder*.

#### Textile industry to get subsidised furnace oil: gas on rotational basis during winter

The government will provide subsidised furnace oil to the textile industry for three months and divide textile industry into different zones to provide gas on rotational basis this winter, well placed sources told *Business Recorder* on Thursday. The government assured the textile industry that it would provide surplus furnace oil for the captive power plants (CPPs) during the peak winter months.

## ADB signs trade financing accords with four banks

The Asian Development Bank (ADB) has signed trade financing agreements with four Pakistan banks. The agreements with Bank Alfalah Limited, Faysal Bank Limited, Habib Metropolitan Bank Limited, and United Bank Limited follow similar agreements had signed in mid May with five other Pakistan banks, said ADB press release here on Thursday.

#### Deadly wave of attacks: gunmen, bombs hit five sites: 39 dead

Teams of gunmen launched coordinated attacks on three law enforcement facilities in Lahore and car bombs hit two other cities Thursday, killing a total of 39 people in an escalating wave of anti-government violence. The bloodshed, aimed at scuttling a planned offensive into the Taliban heartland near the Afghan border.

## UK stands 'shoulder to shoulder': Brown

Britain stands "shoulder to shoulder" with Pakistan following the latest attacks there in which 39 people died Thursday, Prime Minister Gordon Brown's spokesman said. Brown wrote to President Asif Ali Zardari after militants unleashed coordinated attacks on Pakistani police, storming offices in Lahore and bombing a north-west station to escalate 11 days of carnage.

#### Obama 'concerned' over attacks

US President Barack Obama is concerned over the loss of life in new militant attacks in Pakistan, the White House said Thursday, adding the strikes underscored the threat from extremists. "The president is always concerned when there's a loss of innocent civilian life," said White House deputy spokesman Bill Burton as Obama flew to New Orleans on Air Force One.

#### **Enemies hiring killers: Malik**

The Federal Interior Minister Rehman Malik said Thursday that the enemy forces are trying to destabilise Pakistan by hiring murderers for terrorist attacks. The Interior Minister, who dashed to the city and visited the affected sites including the FIA building and Elite Police Training Centre in the evening, said the government was fully vigilant to the situation and it would not let the enemies of Pakistan to move scot-free.

#### Islamabad and Istanbul agree to start talks on FTA

Pakistan and Turkey on Thursday agreed, in principle, to start negotiations on a free trade agreement (FTA), expected to be the top agenda item during Turkish Prime Minister Tayyip Erdogan's visit to Islamabad within next 10 days. However, Turkey, prior to initiating talks on the much desired FTA between the two countries, will have to seek permission from the European Union (EU).

## FBR to carefully handle cases of under-reporting

The Federal Board of Revenue (FBR) has taken a policy decision to carefully handle cases of under-reporting of sales tax to give priority to those cases where there is a visible evidence of short-payment of sales tax. Sources told *Business Recorder* here on Thursday the FBR had informed the Ministry of Finance about the monitoring plan to check the compliant and non-compliant taxpayers.

#### Kishenganga project: India invites Pakistan for talks

India has invited Pakistan for talks over controversial Kishenganga project, being built by it in occupied Kashmir on Neelum river, a tributary of Jhelum river. Pakistan has raised its serious concerns over the design of the dam describing it a violation of Indus Basin Treaty as it will affect normal flow of water down stream.

# Nawaz Sharif rejects conditionalities

Pakistan Muslim League-Nawaz (PML-N) Chief Mian Nawaz Sahrif while rejecting the conditionalities attached with US aid under the Kerry-Lugar Bill, said that a national action plan should be devised in the parliament to accept or reject any foreign aid/loan given to Pakistan.

#### NRO to be presented in National Assembly today: Babar Awan

Federal Minister for Parliamentary Affairs Babar Awan on Thursday said that the government has decided in principle to present National Reconciliation Ordinance (NRO) in National Assembly (NA) for debate. Talking to reporters outside the National Assembly, Awan said the government would table the ordinance in National Assembly on Friday (today). "The NRO will be presented in National Assembly tomorrow in compliance with the orders of Supreme Court of Pakistan," Baber Awan said.

### US banking sector delivers more earnings

The US banking industry delivered more positive earnings surprises Thursday, as Goldman Sachs and Citigroup posted strong results in signs of a rebound in the troubled sector critical to economic recovery. Citigroup topped expectations, posting a third-quarter profit of 101 million dollars.

#### India and Russia agree on arms deal worth over \$5 billion

India and Russia agreed two military pacts on Thursday, including a 10-year deal on weapons, aircraft and maintenance contracts potentially worth at least \$5 billion, Indian defence officials said. India's Defence Minister A.K. Antony and his Russian counterpart Anatoly Serdyukov agreed the deals in Moscow.
